#### Hazard Statements

Highly flammable liquid and vapor  
Causes serious eye irritation

#### Precautionary Statements - Prevention

Keep away from heat/sparks/open flames/hot surfaces – No smoking  
Keep container tightly closed  
Ground/bond container and receiving equipment  
Use explosion-proof electrical/ventilating/lighting/equipment  
Use only non-sparking tools  
Take precautionary measures against static discharge  
Wear protective gloves and eye protection  
Wash thoroughly after handling  
Avoid breathing dust/fumes/gas/mist/vapors/spray  
Use only outdoors or in a well-ventilated area

#### Precautionary Statements - Response

IF ON SKIN (or hair): Remove/Take off immediately all contaminated clothing. Rinse skin with water/shower  
In case of fire: Use dry sand, dry chemical or alcohol-resistant foam for extinction  
IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do – continue rinsing  
If eye irritation persists: Get medical advice/attention  
If inhaled: Remove person to fresh air and keep comfortable for breathing  
Call a poison center or doctor if you feel unwell

#### Precautionary Statements - Storage

Store locked up  
Store in a well ventilated place. Keep container tightly closed

#### **SECTION 4: FIRST-AID MEASURES**

##### **First Aid Measures**

- General Advice:** Keep out of reach of children. Use with care.
- Eye Contact:** Immediately flush with cool running water for at least 15 minutes while holding eyelids apart. Do not rub affected area. Remove contact lenses if applicable.
- Skin Contact:** None under normal use conditions. If skin irritation occurs: Get medical advice/attention.
- Ingestion:** If swallowed, may cause burning of the mouth, throat and stomach. Call immediately for medical assistance. DO NOT induce vomiting. Rinse mouth with water, then drink 1-2 glasses of water. Never give anything by mouth to an unconscious person.
- Inhalation:** Remove to fresh air.

##### **Most Important Symptoms and Effects**

- Symptoms:** May cause redness and tearing of the eyes. Burning sensation. Inhalation of high vapor concentrations may cause symptoms like headache, dizziness, tiredness, nausea and vomiting. Prolonged contact may cause redness and irritation.

##### **Indication of any immediate medical attention and special treatment needed**

- Note to Physician:** Treat symptomatically.

#### **SECTION 5: FIRE-FIGHTING MEASURES**

##### **Flammable Properties**

- Flammability:** Considered a fire hazard.
- Explosive Prop:** Sensitivity to static discharge. Considered an explosive hazard.

##### **Extinguishing Media**

- Suitable:** Dry chemical. Carbon dioxide (CO<sub>2</sub>). Water spray. Alcohol resistant foam.
- Unsuitable:** Do not use solid water stream as it may scatter and spread fire.

##### **Specific Hazards Arising from Chemical**

- Hazards:** Risk of ignition. Keep product and empty container away from heat and sources of ignition. In the event of a fire, cool tanks with water spray. Fire residues and contaminated fire extinguishing water must be disposed of in accordance with local regulations.

##### **Protective equipment and precautions for fire-fighters**

- Fire-Fight Method:** In the event of a fire, fire-fighters should wear appropriate protective equipment and self-contained breathing apparatus (SCBA).

#### **SECTION 6: ACCIDENTAL RELEASE MEASURES**

**Personal Precautions:** Evacuate personnel to safe areas. Isolate hazard area and deny entry. Stay upwind of spill/leak. Use personal protective equipment. Avoid contact with skin, eyes or clothing. ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Take precautionary measures against static discharges. All equipment used when handling the product must be grounded. Do not touch or walk through spilled material. Ventilate the area.

**Environ. Precautions:** Prevent release to the environment if possible. Dike large spills to prevent material from entering streams or sewer systems.

**Clean-Up Method:** Soak-up with inert absorbent material and place into appropriate container for disposal. Clean contaminated area thoroughly with water. Prevent product from entering drains.

**SECTION 7: HANDLING AND STORAGE**

**Handling:** Use personal protective equipment when needed. Avoid breathing vapors or mists. Keep away from heat, hot surface, sparks, open flames and other ignition sources. No smoking. Use grounding and bonding connection when transferring this material to prevent static discharge, fire or explosion. Use with local exhaust ventilation. Use spark-proof tools and explosion-proof equipment. Keep in an area with sprinklers. Avoid contact with skin, eyes, and clothing. Wash hands before eating, drinking, or smoking. Remove contaminated clothes and wash before reuse. Use in a ventilated area.

**Storage:** Store in closed containers in cool, dry, well-ventilated area. Avoid overheating or freezing. Keep away from heat, sparks, flame and other sources of ignition. Do not store near combustible materials. Keep in an area equipped with sprinklers. Keep in properly labeled containers and out of reach of children.

**Incomp. Materials:** Acids. Strong oxidizing agents. Isocyanates. Chlorine.
